Decision no. 64 /2019 of the Warsaw University of Technology Rector of 21 may 2019

on the tuition fees payable by foreigners starting education in the academic year 2019/2020 in first-cycle, second-cycle or post-graduate programmes at the Warsaw University of Technology

Pursuant to Art. 23 section 1, Art. 79 section 1, 2, 3, and 5 and section 2 point 1 and Art. 163 section 2 of the Act of 20 July 2018 – Law on Higher Education and Science (Journal of Acts item 1668 with further amendments) it is hereby determined as follows:

§ 1

- 1. The following tuition fees (in Euro) payable by foreigners starting education in the academic year 2019/2020 are determined:
 - 1) nominal semester fee (in Euro) in first-cycle, second-cycle programmes for:
 - a) tuition in part-time programmes;
 - b) retaking courses in full-time programmes due to unsatisfactory progress in learning;
 - c) tuition in a foreign language;
 - d) tuition of foreigners in full-time programmes in Polish as the language of instruction,
 - 2) nominal semester fee (in Euro) for tuition in post-graduate programmes, subject to sections 2 and 3, to the following amounts:

- 2. The fee for post-graduate study at the Business School for persons specified in section 1 is determined to be EUR 16 500 for the two-year Executive MBA programme.
- 3. Tuition fees are not payable for education of foreigners in full-time programmes in Polish as the language of instruction, referred to in §1 section 1 point 1 letter d by foreigners who meet the conditions laid down in Art. 324 section 2 of the Act of 20 July 2018 Law on Higher Education and Science (Journal of Acts of 2018, item 1668 with further amendments).
- 4. The fees determined in point 1, i.e., nominal semester fees for first-cycle degree programmes [column 3] and nominal semester fees for second-cycle degree programmes [column 4], hereinafter referred to as the nominal semester fee for the degree programme in a given semester, marked with the symbol k_n, apply to the nominal number of ECTS foreseen in a given semester in the study programme, while the nominal number of ECTS, hereinafter referred to as *n*ECTS, may amount to:
 - 1) basically, 30 ECTS,
 - 2) may be different than 30 ECTS in special cases.
- 5. Subject to points 7-9, the individual semester fee k_s for the first- or second-cycle degree programme according to the programme of study of a given student in a given semester is determined with the following formula:

$$k_s = \frac{k_n}{n ECTS} \cdot l ECTS$$

where: k_s –	individual fee for a given semester of study,
k_n –	nominal semester fee for the study in a given semester,
n ECTS -	nominal number of ECTS points in a given semester determined in the study programme,
l ECTS –	total number of ECTS points for all courses completed by the student from the study programme for a given semester (i.e., in the semester he/she is registered on), from previous and subsequent semesters, and also make-up courses determined by the Dean of the Faculty, both those

completed for the first time and those retaken.

6. In full-time degree programmes, the individual semester fee k_s for tuition in first-cycle or second-cycle programmes according to the study programme of a given student in a given semester referred to in section 5, includes the fee k_p for retaking certain courses in full-time programmes due to unsatisfactory progress in learning. The fee k_p for retaking certain courses in full-time programmes due to unsatisfactory progress in learning is determined with the following formula, subject to sections 7-9:

$k_p = rac{k_n}{n \textit{ECTS}} \cdot p \textit{ECTS}$ where:				
k _p -	fee for courses retaken in a given semester,			
k _n -	nominal semester fee for the study in a given semester,			
n ECTS -	nominal semester fee for the study in a given semester,			
p ECTS –	total number of ECTS points for courses from previous semesters retaken in a given semester.			

- 7. In justified cases, the Dean may apply to the Rector to make the formula laid down in section 5 or 6 more detailed.
- 8. The tuition fees for retaking the last semesters of degree programmes in case of the necessity of consultations on the diploma thesis are:
 - 1) in first-cycle programmes PLN 220 (lump sum);
 - 2) in second-cycle programmes PLN 390 (lump sum).
- 9. The tuition fee (lump sum) for retaking consultations on term papers for first- and second-cycle students is PLN 100.

In economically justified situations, especially when there are greater numbers of foreign

candidates to degree programmes, the Dean of the Faculty, Director of the College, Director of the Business School, as applicable, may apply to the Rector to determine a lower semester fee (in Euro) than the amount specified in § 1 section 1, for candidates admitted to study in a given academic year.

§ 3

For the academic year 2019/2020, a non-returnable fee for admissions proceedings to first-and second-cycle degree programmes for persons specified in section 1 is EUR 200.

§ 4

The decision enters into force upon its signing.
