Decision no. 89/2019  
of the Warsaw University of Technology Rector  
of 24 June 2019

on the tuition fees for courses and other forms of education in the academic year 2019/2020

Pursuant to Art. 23 section 1, Art. 79 section 1 point 1-4 and Art. 163 section 2 of the Act of 20 July 2018 – Law on Higher Education and Science (Journal of Acts item 1668 as amended), it is hereby determined as follows:

§ 1

In the academic year 2019/2020, the following are determined:

- 1) tuition fees for part-time degree programmes in accordance with Annex no. 1,
- 2) tuition fees for full-time degree programmes in English as the language of instruction in accordance with Annex no. 2,
- 3) tuition fees for courses retaken in full-time degree programmes in accordance with Annex no. 3,
- 4) fees for classes not included in the study programme and fees for other forms of education in accordance with Annex no. 4.

**Tuition fees for part-time degree programmes in the academic year 2019/2020**

## 1. The tuition fees laid down in this Annex apply:

- 1) in the academic year 2019/2020, to students admitted on the basis of old regulations, to degree programmes in the academic year 2018/2019 and earlier:
  - a) students who are Polish citizens,
  - b) students who are foreigners and were admitted to degree programmes "on the basis of regulations applicable to Polish citizens" laid down in Art. 43 section 2 of the Act of 27 July 2005 – Law on Higher Education (Journal of Acts of 2017, item 2183 as amended);
- 2) over the whole nominal duration of study, to students admitted to degree programmes in the academic year 2019/2020, who are Polish citizens or citizens of European Union member states.

## 2. In the academic year 2019/2020, the following nominal semester tuition fees shall be payable for part-time degree programmes:

3. The nominal semester fees for education in part-time programmes determined in point 2, marked hereinafter with the symbol  $k_n$ , apply to the nominal number of ECTS foreseen in a given semester in the study programme. The nominal number of ECTS, hereinafter referred to as  $n$ ECTS, may amount to:
  - basically 30 ECTS;
  - the nominal number of ECTS credits per semester may be lower than 30 when the part-time study programme includes a greater number of semesters than the study programme of the full-time degree programme;
  - the nominal number of points in a semester may be different than 30 in special cases.
4. Subject to sections 5-7, the individual semester fee  $k_s$  for education in part-time programmes according to the study plan, for a given student in a given semester is determined with the following formula:

$$k_s = \frac{k_n}{n \text{ ECTS}} \cdot l \text{ ECTS}$$

where:

$k_s$ –	individual fee for a given semester of study,
$k_n$ –	nominal semester fee for a given semester of study,
$n \text{ ECTS}$ –	nominal number of ECTS in a given semester determined in the study programme,
$l \text{ ECTS}$ –	total number of ECTS: courses completed by the student from the study programme for a given semester (i.e., in the semester he/she is registered on), from previous and subsequent semesters, and also make-up courses determined by the Dean of the Faculty, both those completed for the first time and those retaken

5. In justified cases, the Dean may apply to the Rector to make the formula laid down in point 4 more detailed.
6. The tuition fees for retaking the diploma semester in part-time degree programmes, in case of the necessity of consultations on the diploma thesis, are:
  - 1) in first-cycle study PLN 220 (lump sum);
  - 2) in second-cycle study PLN 390 (lump sum).
7. The fee for consultations on mid-term papers in first- and second-cycle study, if retaken, is a lump sum of PLN 100.

### Tuition fees for full-time degree programmes in English as the language of instruction in the academic year 2019/2020

1. The tuition fees laid down in this Annex apply:
  - 1) in the academic year 2019/2020, to students admitted on the basis of old regulations, to degree programmes in the academic year 2018/2019 and earlier:
    - a) students who are Polish citizens,
    - b) students who are foreigners and were admitted to degree programmes "on the basis of regulations applicable to Polish citizens" laid down in Art. 43 section 2 of the Act of 27 July 2005 – Law on Higher Education (Journal of Acts of 2017, item 2183 as amended);
  - 2) over the whole nominal duration of study, to students admitted to degree programmes in the academic year 2019/2020, who are Polish citizens or citizens of European Union member states.

3. The nominal semester fees for education in full-time programmes in English as the language of instruction determined in point 2, marked hereinafter with the symbol  $k_n$ , apply to the nominal number of ECTS foreseen in a given semester in the study programme. The nominal number of ECTS, hereinafter referred to as  $nECTS$ , may:
  - amount to basically 30 ECTS;
  - be different than 30 in special cases.
4. Subject to sections 5-8, the individual semester fee  $k_s$  for education in full-time programmes in English as the language of instruction according to the study plan, for a given student in a given semester is determined with the following formula:

$$k_s = \frac{k_n}{n \text{ ECTS}} \cdot l \text{ ECTS}$$

where:

$k_s$ –	individual fee for a given semester of study,
$k_n$ –	nominal semester fee for a given semester of study,
$n \text{ ECTS}$ –	nominal number of ECTS in a given semester determined in the study programme,
$l \text{ ECTS}$ –	total number of ECTS: courses completed by the student from the study programme for a given semester (i.e., in the semester he/she is registered on), from previous and subsequent semesters, and also make-up courses determined by the Dean of the Faculty, both those completed for the first time and those retaken

5. In justified cases, the Dean may apply to the Rector to make the formula laid down in point 4 more detailed.
6. The tuition fees for retaking the diploma semester in full-time degree programmes in English as the language of instruction, in case of the necessity of consultations on the diploma thesis, are:
  - 1) in first-cycle study PLN 220 (lump sum);
  - 2) in second-cycle study PLN 390 (lump sum).
7. The fee for consultations on mid-term papers in first- and second-cycle study, if retaken, is a lump sum of PLN 100.
8. The provisions of point 4 do not apply to full-time degree programmes in English as the language of instruction *with no additional fee* connected with higher tuition costs in the academic year 2019/2020.

### Tuition fees for courses retaken in full-time degree programmes due to unsatisfactory progress in learning in the academic year 2019/2020

1. The tuition fees laid down in this Annex apply:
  - 1) in the academic year 2019/2020, to students admitted on the basis of old regulations, to degree programmes in the academic year 2018/2019 and earlier:
    - a) students who are Polish citizens,
    - b) students who are foreigners and were admitted to degree programmes "on the basis of regulations applicable to Polish citizens" laid down in Art. 43 section 2 of the Act of 27 July 2005 – Law on Higher Education (Journal of Acts of 2017, item 2183 as amended);
  - 2) over the whole nominal duration of study, to students admitted to degree programmes in the academic year 2019/2020, who are Polish citizens or citizens of European Union member states.
2. The tuition fee for retaking a course is the sum of fees for classes other than a lecture (product of the number of hours of classes and the fee for one hour of classes retaken) and the lump sum for the lecture (if foreseen in the study programme for the course).
3. If a course is failed, the fee for retaking it is determined in accordance with section 4, taking into account the number of hours of the course specified in the study programme. The fee for retaking the course is payable when the student attends once again the same course or an equivalent course.
4. In the academic year 2019/2020, the following fees for courses retaken due to unsatisfactory progress in learning in full-time degree programmes shall be payable:
