Regulations for awarding the "Christmas Grant 2022" ("Stypendium pod choinkę 2022")

- 1. These Regulations for the "Christmas Grant 2022" specify the criteria for awarding the grant and indicate its recipients.
- 2. The "Christmas Grant" is a special grant awarded to students and doctoral students at the Warsaw University of Technology involved in promoting the University and building its positive image, in compliance with item 4 of these Regulations.
- 3. Laureates of previous editions may not apply for the "Christmas Grant".
- 4. The "Christmas Grant" may be awarded to students and doctoral students who between 2020 and 2022
 - 1) have represented the Warsaw University of Technology in science competitions:
 - a) national (weighted score 1-3)
 - b) international (weighted score 1-4)

and won the first/second/third place or a distinction.

- 2) have represented the Warsaw University of Technology in artistic, sports, or other competitions or contests:
 - a) national (weighted score 1-3)
 - b) international (weighted score 1-4)

and won the first/second/third place or a distinction.

- 3) have participated in projects, initiatives, and events promoting the Warsaw University of Technology (weighted score 1-3).
- 4) have actively contributed to the popularisation of scientific concepts among children, adolescents, and adults (weighted score 1-3).
- 5) have become involved in social actions and charity work (weighted score 1-3).
- 6) Additional points will be awarded for a diligently conducted presentation (weighted score 1-3).
- 5. The "Christmas Grant" will be awarded to Candidates with the highest score.
- 6. The grant is financed by the resources collected during the Warsaw University of Technology Christmas Fair and the grant laureates receive it as a one-time payment.
- 7. The "Christmas Grant" is awarded by the Award Committee of the Grant Fund (hereinafter referred to as "Award Committee") whose members are:
 - 1) Vice-Rector for Student Affairs of the Warsaw University of Technology chairperson
 - 2) Chancellor of the Warsaw University of Technology
 - 3) head of the Communication and Promotion Office
 - 4) a representative of SSPW
 - 5) representatives of the Communication and Promotion Office
- 8. The Award Committee will determine the number and amount of the grants.

- 9. The Award Committee may award in-kind prizes to the grantees.
- 10. Candidates may be nominated by the University authorities, deans of faculties, and by the students or doctoral students themselves on their behalf.
- 11. Candidates' nominations may be submitted to the Office for Communication and Promotion in an electronic form to eventy@pw.edu.pl by a closing date indicated by the Committee.
- 12. The application will include:
 - 1) a multi-media presentation prepared in accordance with the guidelines below:
 - a) Slide 1 must contain the candidate's data, i.e. first name, surname, faculty/doctoral school, field and year of study, and e-mail address in the domain pw.edu.pl.
 - b) Any slides that follow must comply with the criteria in item 4.
 - 2) a candidate's declaration on granting or refusing consent for the use of their image for marketing purposes, constituting Appendix No. 1 to these Regulations
 - 3) information on the person nominating a Candidate, constituting Appendix No. 2 to these Regulations (for Candidates who do not nominate themselves)
- 13. The Award Committee will select the laureates after analysing the submitted documents.
- 14. In exceptional situations, the Award Committee may invite a Candidate to an individual meeting.
- 15. The Award Committee will immediately inform the laureates about the verdict via e-mail as soon as it reaches a decision on awarding grants.
- 16. The Award Committee's decision is final, and no appeal may be taken against it.
- 17. The award ceremony will take place at a time set by the Award Committee.
- 18. The grant is paid as a transfer to a bank account indicated by the grantee.
- 19. Pursuant to Article 30 section 1 item 2 of the Act of 26 July 1991 Law on Personal Income Tax (Journal of Laws of 2021 item 1128 with later amendments), a lump sum income tax of 10% will be deducted from that amount if the amount of the grant paid to the laureate exceeds PLN 2 000.
